2 Investments

At 31 January 2015 and 2014 investments comprised the cost of shares in Clugston Transport Limited, which is wholly owned and dormant.

3 Allotted and issued share capital

The allotted, called up and fully paid share capital of the company at 31 January 2015 and 2014 comprised 100 ordinary shares of £1 each.

4 Profit and loss account

The company has not traded during the period and accordingly has made neither a profit nor a loss. No profit and loss account has therefore been prepared.

5 Parent undertaking and ultimate parent company
