AND: West Somerset Railway PLC of The Railway Station, Minehead, Somerset TA24 5BG Company Number **01010188** ("the borrower")

WITNESSES as follows:-

IN CONSIDERATION of the Lender loaning £70,000 Seventy Thousand Pounds ("the Loan") to the Borrower and the Borrower offering Guarantee to repay the Loan to the Lender both parties agree to keep perform and fulfil the promises and conditions set out in this Agreement and Guarantee.

1. Loan amount

The Lender agrees to loan the sum of seventy thousand (£70,000 GBP) to the Borrower and the Borrower agrees and guarantees to repay this principal amount to the Lender together with interest. The interest on the loan being at an annual percentage rate of 0.5%. above Bank of England base rate to be adjusted on 1st April 2021 and at six monthly intervals thereafter to reflect any changes to said base rate. 3. Repayments


