1. GENERAL INFORMATION

The Company is a private limited company incorporated and domiciled in England. The address of its registered office is Wigmore House, Wigmore Lane, Luton, Bedfordshire, LU29TN. The Company's registered number is 1019392.

The Company continued to be a dormant entity within the TUI AG Group of companies (the "Group").

2. BASIS OF PREPARATION

These separate financial statements have been prepared under the historical cost convention, on a going concern basis and in accordance with the Companies Act 2006 and The Financial Reporting Standard applicable in the UK and Republic of Ireland ("FRS 102").

FRS 102

The financial statements are presented in the Company's functional currency of Sterling, rounded to the nearest pound.
