1 General information

Pillar-Wedge Group Limited is a company incorporated in England & Wales under the Companies Act. The address of the registered office is given on the company information page. The nature of the company's operation and its principal activity is shown in the directors' report.

4 Contingent liabilities

The parent and certain subsidiary undertakings have entered into unlimited cross guarantees for bank facilities. The combined liability at 31 March 2019 amounted to £Nil (2018 - £Nil).
