Pursuant to Chapter 2 of Part 13 of the Companies Act 2006, the directors of the Company propose that the following resolution is passed as a special resolution ('Resolution').

#### SPECIAL RESOLUTION


##### Reduction of Capital

- (1) That the paid up capital of the Company be reduced from £1,500,000 divided into 6,000,000 ordinary shares of £0.25 each, to £25, divided into 100 ordinary shares of £0.25 each by cancelling and extinguishing 5,999,900 ordinary shares in the capital of the Company and crediting the relevant amount (£1,499,975) to the Company's distributable reserves.
- (2) That the paid up capital of the Company be further reduced from £25, divided into 100 ordinary shares of £0.25 each, to £1, divided into 100 ordinary shares of £0.01 each, by cancelling and extinguishing capital to the extent of £0.24 on each issued fully paid-up ordinary share in the Company and reducing the nominal value of each issued fully paid-up ordinary share from £0.25 to £0.01, and crediting the relevant amount (£24) to the Company's distributable reserves.
