

Short particulars

Hamilton Rentals Limited (the "Chargor") covenants to discharge on demand the Charger's Obligations and as a continuing security for such discharge with full title guarantee charges to RBC Bank (USA) (the "Beneficiary") by way of fixed charge

a) to the extent the same are not form time to time the subject of a valid legal assignment pursuant to Clause 2.2, its Receivables; and b) the proceeds of any insurance from time to time relating to the Receivables.

"Chargor's Obligations" means all the Chargor's liabilities to the Beneficiary of any kind in any currency (whether present or future actual or contingent and whether incurred alone or jointly with another) together with the Beneficiary's charges commission and Interest and the Expenses but excluding any liabilities which if included would cause the Deed and the obligations and benefits contained in it to be unlawful.

Clause 2.2 states that The Chargor with full title guarantee assigns absolutely, subject to a proviso for re-assignment on redemption, the Receivables to the Beneficlary."

"Receivables" means all book and other debts and each sums paid or payable or any other proceeds or realisations receivable in respect of such debts or other choses in action from time to time owing to the Chargor by its trade and/or other creditors

"Interest" means interest in relation to the Guaranteed Obligations a) at all times while the Loan and Security Agreement remains in full force and effect, at the Default Rate under and as defined in the relevant Promissory Note (as defind in the Loan and Security Agreement) relating to the relevant Guaranteed Obligations, or b) at any time thereafter, at a rate equal to the greater of (i) 9% (nine) per annum and (ii) 8% (eight) per annum above the LIBOR for the relevant Required Currency

"Expenses" means all expenses (on a full indemnity basis) together with any VAT incurred by the Beneficiary or any receiver at any time in connection with the Charged Property or the Chargor's Obligations or in taking or perfecting this Deed or any other Finance Document or in preserving defending or enforcing (or considering or attempting the preservation, defence or enforcement of) the security created by this Deed or any other Finance Document or in exercising any right or power under this Deed or any other Finance Document or otherwise with Interest from the date they are incurred.

"Guaranteed Obligations" as defined in the relevant Promissory Note (as defined in the Loan and Security Agreement).

"Loan and Security Agreement" means the amended and restated loan and security agreement dated as of 29th day of March 2010 by and between the Borrower and the Beneficlary

"Required Currency" means the currency or currencies in which the Chargor's Obligations are expressed from time to time.
