Solicitor dated the 6 October 2017

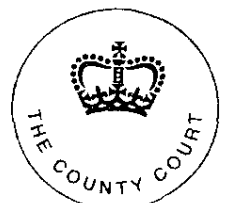
AND upon the Claimant by his Solicitors undertaking to

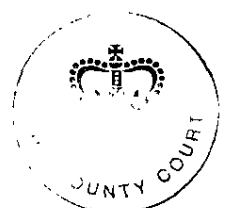


AND UPON the Solicitors for the Claimant and the Registrar of Companies
