NOTES TO THE ABBREVIATED FINANCIAL STATEMENTS FOR THE YEAR ENDED 24TH JUNE 2016

1) ACCOUNTING POLICIES

a) Accounting convention

The financial statements have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective January 2015). The principal accounting policies are set out below.

b) Turnover

Turnover represents service charges receivable.

c) Fixed asset expenditure

All additions and improvements on the building and its facilities are written off directly to the income and expenditure account under exceptional costs, which includes other non-standard maintenance expenses.

d) Income and Expenditure

The company has no income or expenditure in its own right, all transactions in the year being related to the maintenance of the common parts in accordance with the lease. Service charges collected are held on trust for the purpose of meeting the relevant costs in relation to the property in accordance with the provisions of section 42 of the Landlord and Tenant Act 1987.

2) MEMBERSHIP CAPITAL

The company is limited by guarantee and has no share capital.

The number of current members is 103 and in the event of the winding up of the company a maximum of £1 may be contributed by current members and those who have ceased membership in the preceding twelve months.
