- (1) EMI GROUP HOLDINGS (UK) LIMITED (registered number 315108) whose registered office at 4 Tenterden Street, London W1A 2AY (the "Seller"); and
- (2) VIRGIN RECORDS LIMITED (registered number 1070953) whose registered office is at Kensal House, 553-579 Harrow Road, London W10 4RH (the "Company").

### BACKGROUND:

- (A) The Company is a company limited by shares incorporated in England.
- (B) Details of the authorised and issued share capital of the Company are set out in the Schedule.
- (C) The Seller is the legal and beneficial owner of 100,000,000 'C' Cumulative Convertible Participating Preference Shares of FFr 10 each in the share capital of the Company.
- (D) The Company has agreed to re-purchase all of the 'C' Cumulative Convertible Participating Preference Shares held by the Seller.

### 1. INTERPRETATION

In this Agreement:

#### 2. AGREEMENT TO SELL AND PURCHASE

The Seller shall sell as legal and beneficial owner with full title guarantee and the Company shall purchase the Shares free from all claims, charges, liens, encumbrances and equities together with all rights attached or accruing to those shares.

#### 3. PURCHASE PRICE

The purchase price for the sale of the Shares shall be FFr 1,055,980,000 to be satisfied in cash on Completion.

#### COMPLETION 4.

Completion of the sale and purchase ("Completion") shall take place immediately following execution of this Agreement when:

- (a) the Seller shall hand, or procure to be handed, to the Company duly executed instrument of transfer or as it may direct, together with (if appropriate) the share certificate in respect of the Shares;
- (b) the Shares purchased by the Company shall be cancelled by the Company at Completion;
- (c) the Seller hereby irrevocably waives all rights of pre-emption over or other rights to restrict transfer of the Shares converted to him either by the Articles of Association of the Company or in any other way.

#### 5. **GOVERNING LAW**

This agreement shall be governed by and construed in accordance with English Law and the parties agree to submit to the non-exclusive jurisdiction of the English courts.

#### **EXECUTION:**

The parties have shown their acceptance to the terms of this Agreement by executing it at the end of the Schedule.
