

1 Basis of preparation

(a) Compliance with International Financial Reporting Standards ('IFRSs')

The financial statements of the Company comply with UK-adopted international accounting standards and with the requirements of the Companies Act 2006.

Standards adopted during the year ended 31 December 2021

There were no new accounting standards or interpretations that had a significant effect on the Company in 2021. Accounting policies have been consistently applied.

(b) Future accounting developments

There are no new IFRSs and amendments thereto effective from 1 January 2022 and 1 January 2023 which are expected to have a significant impact on the financial statements of the Company.

(c) General information

Canada Square Nominees (UK) Limited is a private limited company domiciled and incorporated in the United Kingdom and registered in England and Wales.

The functional currency of the Company is sterling which is also the presentational currency of the financial statements of the Company.

The financial statements have been prepared on the historical cost basis.

2 Directors' emoluments

The Directors did not receive any emoluments in respect of their services to the Company during the year. The Company has made no loans, guarantees or other such dealings to its directors and others during the year.

3 Related party transactions

There have been no transactions with related parties requiring disclosure in either the current or prior year. The Company is dormant and all statutory fees are paid by another group undertaking.

The ultimate parent undertaking (which is the ultimate controlling party) and the parent undertaking of the largest group of undertakings for which group financial statements are drawn up and of which the Company is a member is HSBC Holdings plc, and the parent undertaking of the smallest such group is HSBC UK Bank plc. The immediate holding company is HSBC UK Bank plc.
