Texidwarf Limited (registered number 1155187) did not trade during the current or preceding period and has made neither profit nor loss, nor any other recognised gain or loss.


For the year ending 31 December 2018 the company was entitled to exemption from audit under section 480 of the Companies Act 2006 relating to dormant companies.
