#### Respective responsibilities of directors and auditors

The directors are responsible for preparing the abbreviated accounts in accordance with Section 444 of the Companies Act 2006. It is our responsibility to form an independent opinion as to whether the company is entitled to deliver abbreviated accounts to the Registrar of Companies and whether the abbreviated accounts have been properly prepared in accordance with the regulations made under that section and to report our opinion to you

# Principal accounting policies

#### **Basis of accounting**

The financial statements have been prepared under the historical cost convention, and in accordance with applicable UK accounting standards

The nature of the company's business is that there are significant deferred revenues which have a direct impact on the net current liabilities position of the company. Current liabilities of £2,785,768 include £1,809,246 deferred revenue related to Daily Brief subscriptions paid in advance by clients but which are non-refundable in any event other than the discontinuance of the company. Excluding deferred revenue related to Daily Brief subscriptions, the company is in a net current asset position of of £899,906 which facilitates the on-going ability of the company to comfortably meet its liabilities as they fall due

The directors are aware of the financial position of the company and have carefully considered the prospects for the business over the next few years by preparing budgets. The key assumption in the budget relates to consultancy income, which has historically fluctuated, and the timing of this work is, by its nature, uncertain. The level of consultancy income forecast is consistent with the levels achieved in recent years. The directors have considered this uncertainty and have developed contingency plans should budgeted levels of consultancy income not be achieved in the 12 months from approval of the financial statements.

The directors are satisfied that it is appropriate to prepare the accounts on a going concern basis and are confident of the future success of the business. The accompanying financial statements do not include any adjustments that might be necessary if the company is unable to continue as a going concern.

The principal accounting policies of the company have remained unchanged from the prior period and are set out below

#### **Cash flow statement**

The directors have taken advantage of the exemption in FRS 1 (revised) from including a cash flow statement in the financial statements on the grounds that the company is wholly owned and its parent publishes a consolidated cash flow statement

#### Turnover

Turnover is the total amount receivable by the company for goods supplied and services provided, excluding value added tax

#### Subscription income

Turnover from subscription income is recognised on a straight line basis over the length of the subscription. Deferred income represents the element of subscription income relating to future accounting periods

#### Consultancy income

In the case of consultancy contracts, turnover reflects the contract activity during the year and represents the proportion of total contract value which costs incurred to date bear to total expected contract costs

#### **Conference Income**

Turnover from conferences represents income generated by the Oxford Analytica International Conference held annually at Oxford University and other conferences

#### **Depreciation**

Depreciation is calculated so as to write off the cost of an asset, less its estimated residual value, over the useful economic life of that asset as follows

Freehold property - 2%
Fixtures and fittings - 20%
Motor vehicles - 20%
Computer equipment - 20%

#### Leasing and hire purchase commitments

Assets held under finance leases, which are leases where substantially all the risks and rewards of ownership of the asset have passed to the company, and hire purchase contracts, are capitalised in the balance sheet and are depreciated over their useful lives. The capital elements of future obligations under the leases and hire purchase contracts are included as liabilities in the balance sheet.

The interest elements of the rental obligations are charged in the profit and loss account over the periods of the leases and hire purchase contracts and represent a constant proportion of the balance of capital repayments outstanding

Rentals payable under operating leases are charged in the profit and loss account on a straight line basis over the lease term

#### **Pension costs**

The company operates a defined contribution pension scheme for employees. The assets of the scheme are held separately from those of the company. The annual contributions payable are charged to the profit and loss account.

#### **Deferred taxation**

Deferred tax is recognised on all timing differences where the transactions or events that give the company an obligation to pay more tax in the future, or a right to pay less tax in the future, have occurred by the balance sheet date. Deferred tax assets are recognised when it is more likely than not that they will be recovered. Deferred tax is measured using rates of tax that have been enacted or substantively enacted by the balance sheet date.

#### Foreign currencies

Monetary assets and liabilities in foreign currencies are translated into sterling at the rates of exchange ruling at the balance sheet date. Transactions in foreign currencies are translated into sterling at the rate of exchange ruling at the date of the transaction. Exchange differences are taken into account in arriving at the operating profit.

#### Financial instruments

Financial liabilities and equity instruments are classified according to the substance of the contractual arrangements entered into. An equity instrument is any contract that evidences a residual interest in the assets of the entity after deducting all of its financial liabilities.

Where the contractual obligations of financial instruments (including share capital) are equivalent to a similar debt instrument, those financial instruments are classed as financial liabilities. Financial liabilities are presented as such in the balance sheet. Finance costs and gains or losses relating to financial liabilities are included in the profit and loss account. Finance costs are calculated so as to produce a constant rate of return on the outstanding liability.

Where the contractual terms of share capital do not have any terms meeting the definition of a financial liability then this is classed as an equity instrument. Dividends and distributions relating to equity instruments are debited direct to equity

#### **Barter transactions**

The company has continued to enter into barter transactions during the period in which Daily Brief services and conference sponsorship are provided in return for sales and marketing related services (including advertising and membership fees)

Barter transactions are recorded as turnover at an amount equal to the estimated fair value of the services received or of the publication provided, depending on which is more clearly evident. A corresponding amount is recorded as a cost of sales when the services received are consumed. The lower of the estimated fair value of the services received or the estimated fair value of the subscription/sponsorship was £154,000 (2009 £154,000)

#### **Share-based payments**

The group issues share options and warrants to certain employees. These payments are measured at fair value at the date of grant, using an appropriate valuation model. The fair value is then expensed on a straight line basis over the vesting period, based on the group's estimate of the number of shares that will eventually vest, updated at each balance sheet date.
