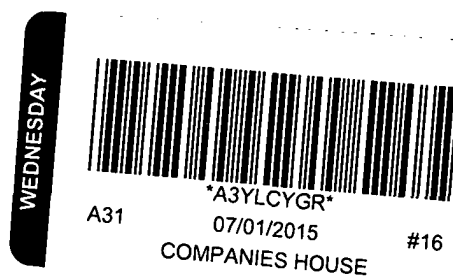

The company's ultimate parent undertaking is Yoplait SAS, jointly owned until June 30, 2011 by Group Sodiaal S.A. and Financiere Tramontane, the first of which is incorporated in France, the second in Luxembourg. From July 1, 2011, Yoplait SAS is jointly owned by Sodiaal Produits Frais SPV (France) and Y.O.C.V (Netherlands).
