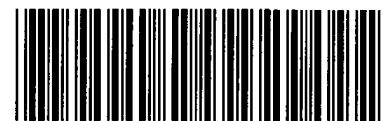





4. PARENT COMPANY

The company's immediate parent company is Yoplait UK Limited (formerly Yoplait Dairy Crest Limited). The company's ultimate parent undertaking is Yoplait SAS, jointly owned until June 30, 2011 by Group Sodial S.A. and Financiere Tramontane, the first of which is incorporated in France, the second in Luxembourg. From July 1, 2011, Yoplait SAS is jointly owned by Sodial Produits Frais SPV (France) and Y.O.C.V (Netherlands). The company's results are included in the consolidated financial statements of Yoplait SAS, copies of which are available from its registered office: 150 rue Gallieni, 92641 Boulogne-Billancourt, France.
