1 Accounting policies

Basis of preparation

Grafton Merchanting Distribution Limited (the "Company") is a company incorporated and domiciled in the United Kingdom.

The Company is exempt by virtue of \$400 of the Companies Act 2006 from the requirement to prepare group financial statements. These financial statements present information about the Company as an individual undertaking and not about its group.

These financial statements are prepared in accordance with Financial Reporting Standard 101 Reduced Disclosure Framework ("FRS 101"). The amendments to FRS 101 (2013/14 Cycle), issued in July 2014 and effective immediately, have been applied.

In preparing these financial statements, the Company applies the recognition, measurement and disclosure requirements of International Financial Reporting Standards as adopted by the EU ("Adopted IFRSs"), but makes amendments where necessary in order to comply with the Companies Act 2006 and has set out below where advantage of the FRS 101 disclosure exemptions has been taken.

In these financial statements, the Company has applied the exemptions available under FRS 101 in respect of the following disclosures:

- Comparative period reconciliations for share capital.
- The effects of new but not yet effective IFRSs;
- Disclosure in respect of the compensation of Key Management Personnel.
- Disclosures in respect of transactions with wholly owned subsidiaries.

The accounting policies set out below have, unless otherwise stated, been applied consistently to all periods presented in these financial statements.

The Company's ultimate holding undertaking, Grafton Group plc, includes the Company in its consolidated financial statements. The consolidated financial statements of Grafton Group plc are prepared in accordance with International Financial Reporting Standards and are available to the public.

The financial statements have been prepared in sterling.

Measurement convention

The financial statements are prepared on the historical cost basis.

Investments

The company has applied the exemption available under IFRS 1 to carry investments in fellow subsidiaries at the previous GAAP carrying value. Investments are, therefore, stated at cost less any provisions for permanent diminution in value.

The key judgement impacting this Company is over the recoverability of amounts due from group companies. The Directors have assessed the amounts due from group companies and believe that all balances will be recovered in full in the future.
