

1. Accounting Policies

The following accounting policies have been applied consistently in dealing with items that are considered material to the Company's accounts.

Basis of preparation

The accounts have been prepared in accordance with the Financial Reporting Standards for Smaller Entities (effective April 2008).

Related Parties

The company is a wholly owned subsidiary of Scottish Friendly Assurance Society Ltd, following the transfer of business of Marine and General Mutual Life Assurance Society on 1 June 2015. There have been no transactions between the Company and its ultimate parent undertaking.
