AND UPON HEARING Counsel for the Applicants and the Solicitor for the Registrar of Companies (the Respondent)

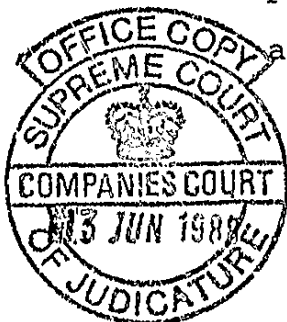
AND UPON READING the evidence

AND the Applicants by their Counsel undertaking within one month of the restoration of the name of the Company to the Register of Companies:-

(1) To procure delivery to the Registrar of Companies in respect of each financial year of the Company determined by reference to its accounting reference period ended the 30th June in each of the years 1986

and 1987 a copy of every document to be comprised in



the accounts of the Company. (Section 239, and for a small or medium sized Company within the meaning of Section 248 Schedule 8 (Part 1), of the Companies Act, 1985).

(2) To forward to the Registrar of Companies a copy of the annual return of the Company for each of the years 1986 and 1987 in the prescribed form and signed by both a director and the secretary of the Company (Sections 363 and 365 of the Companies Act 1985) AND

(3) To deliver to the Registrar of Companies a Return of Allotments in the prescribed form (Section 88 of the Companies Act 1985).

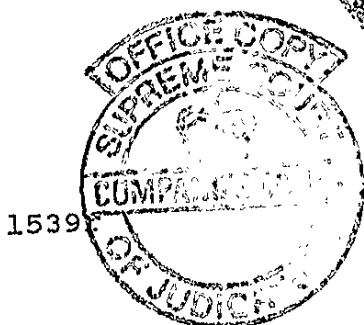
IT IS ORDERED that the name of the above-named ROBIN SYMES LIMITED be restored to the Register of Companies
