The declaration of solvency, sworn by the directors prior to the commencement of the liquidation, showed a debt totalling £100 due from DFS Trading Limited. The debt has been distributed in specie by assignment to DFS Furniture Company Limited, the sole shareholder of the Company (see "Distributions" below)

The Company had no known creditors. A notice to creditors to prove their claims in the liquidation was advertised in The London Gazette on 24 June 2015. No creditors were forthcoming as a result of this advertisement.

**Tax**

The Company's tax advisors advised that the Company had dormant corporation tax status. Following their appointment, the Joint Liquidators sought and received confirmation from HM Revenue and Customs ("HMRC") that the Company had no outstanding corporation tax returns or liabilities, that it would not raise enquiries into any pre or post liquidation periods and that it had no objection to the Liquidators calling a final meeting of members to conclude the liquidation.

A similar assurance was sought and received from HMRC in respect of PAYE and VAT matters.

**Distributions**

On 27 May 2016 the Joint Liquidators declared a first and final distribution of the assets of the Company to DFS Furniture Company Limited, as the sole beneficial shareholder of the Company.

The distribution was a distribution in specie of the debt of £100 due to the Company by DFS Trading Limited.

**Joint Liquidators' remuneration and expenses**

A written resolution was passed on 10 June 2015 that the remuneration of the Joint Liquidators be fixed at their normal charging rates according to the time properly spent by them and members of their staff in attending to matters arising in the winding up of the Company.
