## **Statement of directors' responsibilities**


The company was entitled to exemption under section 249A(1) of the Companies Act 1985 from the requirement to have its accounts for the year ended 5 April 2002 audited.

No notice has been deposited under section 249(B) of that Act requiring an audit in relation to the company's accounts for that financial year.


The directors acknowledge their responsibility for:
