Report of the Trustees
for the Year Ended 31st December 2022

The trustees who are also directors of the charity for the purposes of the Companies Act 2006, present their report with the financial statements of the charity for the year ended 31st December 2022. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

OBJECTIVES AND ACTIVITIES

Objectives and aims

The principal activity of the charity is the provision of independent and unbiased confidential advice, reassurance and education to women with hormonal, gynaecological and related problems as set out in the governing document. The purpose of these services is to help to relieve suffering and improve quality of life.

ACHIEVEMENT AND PERFORMANCE

The board advises income of £407 and no expenses resulting in a surplus of £407 (2020 - deficit £412) for the year.

FINANCIAL REVIEW

Funds in deficit

From 5th July 2012 the operating responsibilities of the charity were passed to the British Menopause Society, who continue to support this charity.

The Women's Health Concern has been retained as a charity in its own right to safeguard future donations and legacies and to protect the BMS from unlikely future claims.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

The charity is controlled by its governing document, a deed of trust, and constitutes a limited company, limited by guarantee, as defined by the Companies Act 2006.

Recruitment and appointment of new trustees

New trustees are recruited when the board identifies a skills gap. New appointments are formally ratified at a board meeting. Newly appointed trustees are inducted to the policies and procedures of the charity by the chief executive and training courses are offered as appropriate.

Organisational structure

Day to day management of the charity is delegated to the honorary chief executive, Patrick Shervington, to whom the board wishes to express its gratitude for performing a wide range of duties on a voluntary basis.

Independent examiner's report to the trustees of Women's Health Concern Limited ('the Company')

1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charitable company, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

These accounts have been prepared on a going concern basis. The charity's activities were transferred into the activities of the British Menopause Society on 5th July 2012.

Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Taxation

The charity is exempt from corporation tax on its charitable activities.

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.
