#### Notes

- An annual return is required for every collendar year. If the company has a share capital the date of this return must be the 14th day after the date of the annual general meeting. If it does not have a share capital the date of this return must be a date not more than 42 days after the annual general meeting.

- (b) a body corporate of which the company making the return was a wholly-owned subsidiary;

- (c) a wholly-owned subsidiary of the company making the return; or
