PROGRESS IN THE PERIOD

Asset realisations

No assets have been realised during the Period.

The only assets in the Liquidations are intercompany balances, as shown on the enclosed receipts and payments accounts at Appendix C. These will be distributed in specie to the respective members of the Companies prior to the closure of the Liquidations.

During the Period, three of the Companies; E. Coleman & Co Limited, Coleman Holdings Limited & Lucas Fettes and Partners Limited, received first and final distributions in specie from their subsidiaries as shown on the enclosed receipts and payments accounts at Appendix C. These subsidiaries had been placed into members' voluntary liquidation previously, and their liquidations are now being concluded.

HMRC

As a matter of course we seek clearances from HMRC's corporation tax team, and the Enforcement and Insolvency Service which deals with VAT and PAYE (as applicable) and which issues HMRC's claims for all taxes

Corporation tax clearance has been received for all Companies. HMRC has confirmed that the Companies have been successfully removed from the VAT group, but to date only ten of the Companies have received EIS clearances.

We were advised by the Companies' parent group, Arthur J. Gallagher Holdings (UK) Limited ('AJG') that none of the Companies had active PAYE schemes. HMRC issued a £400 penalty claim in respect of PAYE for Property Insurance Initiatives Limited ('Pii'), but AJG has further advised that this scheme had been closed, and the penalty could be challenged.

Further to this, HMRC advised that Lucas Fettes and Partners Limited had an outstanding Class 1A NIC return. We have liaised with AJG and understand that this matter has very recently been resolved.

It should be noted that HMRC have a significant backlog arising from dealing with COVID-19 support schemes during the pandemic, and it is uncertain when the clearances for the remaining Companies will be received.

Creditors

No creditors were anticipated as detailed by the Declarations of Solvency sworn by the Companies' directors. Following the Joint Liquidators' appointment, statutory advertisements were placed in the London Gazette and Times newspaper inviting creditors to submit claims.

Other than the tax matters detailed above, we have only received one claim against Pii in relation to potential mis-selling of an insurance policy. We are liaising with AJG and have jointly engaged legal advisors to deal with the matter. This is still in progress, and at present we do not have any indication of how long the matter may take to be resolved. It should be noted that in the event that Pii is found to be liable, AJG should meet any liability so that Pii will remain solvent.

Return on capital

No distributions have been made to the Companies' members to date. However, as outlined above, first and final distributions in specie will be paid to the members when the Liquidations are in a position to be closed.

Other matters

In addition to the above matters, we have dealt with all statutory matters required by legislation and administrative work incidental to our duties as Joint Liquidators in this Liquidation.

The Joint Liquidators received a request for a change in lease entity in relation to E. Coleman & Co Limited, and a request for more information regarding Coleman Group (Holdings) Limited in relation to ongoing Scottish litigation We are being assisted in these matters by AJG.

Joint Liquidators' remuneration

The Joint Liquidators' remuneration was approved on a time cost basis by the members.

During the Period, time costs of £56,512.45 were incurred over 233.80 hours at an average rate of £241.71 per hour.

As the Companies do not have any cash assets, the costs of the Liquidations, including expenses, will be met by AJG.

A detailed report of the time incurred by the Joint Liquidators and a narrative of the work done during the Period is attached in Appendix D.

Within 14 days of receipt of the request, the Joint Liquidators must provide all of the information asked for, unless they think that:

- disclosure of the information would be prejudicial to the conduct of the Liquidation or might reasonably be expected to lead to violence against any person, or
- they are subject to confidentiality obligations in respect of the information.
