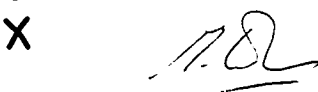

PROGRESS IN THE PERIOD

Asset realisations

No assets have been realised during the period.

The only assets in the liquidations are intercompany balances, as detailed on the attached receipts and payments accounts at Appendix C. These balances will be distributed in specie to the Companies' respective members prior to the closure of the liquidations.

HMRC

We are required to obtain clearances from the Corporation Tax office and the Enforcement & Insolvency Service which deals with VAT and PAYE clearances, and which also issues HMRC's claim for all taxes.

Corporation tax clearance has been received for all Companies. To date only eighteen of the Companies have received EIS clearances. The outstanding EIS clearances are being followed up with HMRC on a regular basis, but it should be noted that HMRC continue to suffer a backlog arising from the COVID-19 pandemic, and it unclear when final clearances will be received.

Creditors

No creditors were anticipated as detailed by the Declarations of Solvency sworn by the Companies' directors. Following the Joint Liquidators' appointment, statutory advertisements were placed in the London Gazette and Times newspaper inviting creditors to submit claims.

As previously reported, we have received a claim against Property Insurance Initiatives Limited in relation to a potential mis-selling of an insurance policy.

The matter is ongoing and at present it is uncertain how long it may take to be resolved, as it appears it may be contingent on the result of pending court cases regarding similar matters. The defence was recently submitted. It should be noted that in the event that Property Insurance Initiatives Limited is found to be liable, AJG (the Companies' parent company) should meet any liability so that the company will remain solvent.

Return to members

No distributions have been made to the Companies' members to date. However, as outlined above, first and final distributions in specie of the intercompany receivables will be declared to the Companies' members when the liquidations are in a position to be closed.

Other matters

In addition to the above matters, we have dealt with all statutory matters required by legislation and administrative work incidental to our duties as Joint Liquidators.

Joint Liquidators' remuneration

The Joint Liquidators' remuneration was approved on a time cost basis by the members.

During the period, time costs of £19,499 were incurred over 68 hours at an average rate of £288 per hour.

As the Companies have no cash assets, the costs of the liquidations, including expenses, will be met by AJG.

A detailed report of the time incurred by the Joint Liquidators and a narrative of the work done during the period is attached in Appendix D.

APPENDIX B

MEMBERS' RIGHTS

Within 21 days of receipt of the Progress Report, members with at least 5% in value of the total voting rights of all members having the right to vote at general meetings of the Companies or any member with the permission of court, may request in writing that the Joint Liquidators provide further information about their remuneration or expenses which have been itemised in the Progress Report.

Within 14 days of receipt of the request, the Joint Liquidators must provide all of the information asked for, unless they think that:

- the time or cost in preparing the information would be excessive, or
- disclosure of the information would be prejudicial to the conduct of the liquidations or might reasonably be expected to lead to violence against any person, or
- they are subject to confidentiality obligations in respect of the information.

The Joint Liquidators are also required to give reasons for not providing all of the requested information.

Members with at least 10% in value of the total voting rights of all members having the right to vote at general meetings of the Companies may, within eight weeks of receipt of the Progress Report, make an application to court that the basis fixed for the Joint Liquidators' remuneration, the remuneration charged, or the expenses incurred by the Joint Liquidators, as set out in the Progress Report, are excessive.
