Statement in respect of the subsidiary companies of 1UTTravel PLC set out in Appendix 1 (together "the Companies") on ceasing to hold office as auditors, pursuant to section 519 of the Companies Act 2006

In accordance with section 519 of the Companies Act 2006 we set out below the circumstances connected with our ceasing to hold office that we consider should be brought to the attention of the Companies' members or creditors.

The audited consolidated financial statements of TIH Travel Ple and its subsidiaries ("the Choup") for the year ended 30 September 2010 contain, inter afta a restatement of its results for the year ended 30 September 2009 and its financial position as that date. The directors have restated the 2009 financial statements because they contained material errors arising from the overstatement of revenues and the mappropriate release of unmatched credits to the income statement. Details of the circumstances giving rise to the restatements are set out in note 1(B)(ii) to the financial statements.

As set out in note I(B)(ii) the major part of the restatement is attributable to failures in the systems and controls of the Group's UK tour operator business over an extended period of time. Most of this period pre-dated our appointment as auditors of the entity concerned. In relation to the release of immatched credits note I(B)(ii) refers to inappropriate analysis, judgements and accounting processes undertaken by the directors of that entity to book the immatched credits in the accounting records of the entity concerned.

We had extensive discussions with the directors of the 1UI Travel Plc over the background to these restatements, the implications arising from them and their disclosure and accounting incatment in the financial statements. Over the course of these discussions our relationship with certain directors became increasingly strained. As a result we were not confident that in the finine we could carry out an audit of the TUI Travel Plc to the appropriate standard, but others may be able to do so. Accordingly we decided not to seek reappointment as auditors of TUI Travel Plc on 29 December 2010 and, further, we have also decided to resign as auditors of the Companies.
