



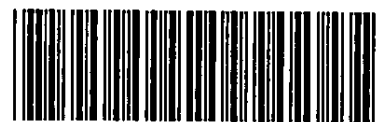
NOTES
