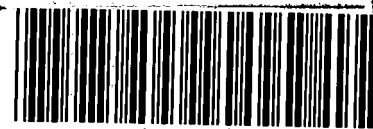

Prescribed particulars	<p>The Special Share is held on behalf of the Secretary of State for Business, Energy & Industrial Strategy ("the Special Shareholder"). Certain provisions of the Company's Articles of Association cannot be amended without the consent of the Special Shareholder. These provisions include the requirement that no foreign person, or foreign persons acting in concert, can have more than a 15% voting interest in the Company, the requirement that the majority of the directors are British, the requirement that decisions of the directors at their meetings, in their committees or via resolution must be approved by a majority of British directors and the requirement that the chief executive and any executive chairman are British.</p> <p>The holder of the Special Share is entitled to attend a general meeting, but the Special Share carries no right to vote or any other votes at any such meeting, other than to speak in relation to any business in respect of the Special Share. Subject to the relevant statutory provisions and the Company's Articles of Association, on a return of capital on a winding-up, the Special Shareholder shall be entitled to repayment of the £1 capital paid up on the Special Share in priority to any repayment of capital to any other members.</p> <p>The holder of the Special Share has the right to require the Company to redeem the Special Share at par or convert the Special Share into one ordinary share at any time.</p>
