3 Going concern

As with most businesses the Company has been impacted by the Coronavirus global pandemic (Covid-19) and throughout the 31st January 2022 accounting period this had an impact on trading operations, customers, suppliers and staff. Whilst the full impact of the global pandemic to the economy, customers and trading operations remains uncertain, the directors believe that the going concern basis of accounting is appropriate.
