

## **1. INTRODUCTION**

- 1.1 Philip Francis Duffy and David John Whitehouse of MCR were appointed Joint Administrators of The Marvellous Group on 29 January 2009 by Zamyra the holder of a qualifying floating charge under paragraph 14 of Schedule B1 to the Insolvency Act 1986.
- 1.2 In accordance with Paragraph 100(2) of Schedule B1 to the Insolvency Act 1986 the functions of the Joint Administrators are being exercised jointly.
- 1.3 This report sets out the circumstances leading up to the appointment of the Joint Administrators and the steps taken by them to date.

## **2. BACKGROUND**

- 2.1 The Company was incorporated on 23 April 1980. Statutory information on the Company and a summary of its financial position is included at Appendix 1.
- 2.2 TMG was founded by friends Judy Lever and Vivienne Pringle as a mail order clothing company specialising in well fitting and fashionable clothes for pregnant women. After initial success selling to expectant mothers the Company branched out into childrens' wear and nursery essentials in which it has continued to trade and become an established brand.
- 2.3 In 1993 the Company opened its first shop and grew rapidly until it had opened 14 stores nationwide.
- 2.4 On 6 July 1995 the business was restructured internally and a separate legal entity Blooming Marvellous Limited ("BM") was incorporated to specifically trade the 14 retail outlets. The Company also expanded the mail order business to incorporate internet sales and traded through the domain name [www.bloomingmarvellous.co.uk](http://www.bloomingmarvellous.co.uk).
- 2.5 There are three entities namely The Marvellous Parent Limited, Blooming Marvellous Limited and The Marvellous Group Limited ("the Group"). Banking facilities were advanced to all three and were secured by debentures and cross guarantees.
- 2.6 TMG and BM shared the same operating and financial infrastructure and for the purposes of trading operated as one entity. It is not possible to clearly delineate the two entities as they have a shared creditor base.
- 2.7 During early 2007 the Group was subject to a management buyout ("MBO") and the founding partners relinquished their stake in the Group.

## **3. EVENTS LEADING UP TO THE ADMINISTRATION**

- 3.1 Soon after the MBO increased focus was placed on developing the product range and the sales strategy was changed to target the higher end of the customer base through an increased pricing strategy.
- 3.2 The Group's turnover has declined in the last two financial years and its financial performance has suffered as a result of reducing BM sales and increasing overheads.
- 3.3 The Group began to experience financial difficulties in the run up to Christmas 2008, during which time BM opened a new store in the Westfield Centre in Hammersmith, West London with onerous

and costly lease commitments. The retail operation of the Group was severely under performing and sales were well below forecast for the first two quarters of the financial year 2008/09.

- 3.4 As a result of the financial difficulties creditor pressure intensified and County Court Summons and statutory demands were being issued against the Group. The number of distressed creditors became unmanageable and a winding up petition was served on TMG in December 2008.
- 3.5 During this time management explored several options for additional investment / working capital funding to be injected into the Company but given the current economic climate management was unable to secure the required funding.
- 3.6 Management took the decision to suspend the website at this point as they could not guarantee that online orders could be fulfilled due to the funding constraints.
- 3.7 With the uncertainty surrounding the Group's cashflow/funding position, the directors took steps to protect the Group's position and filed a notice of intention to appoint Administrators on 22 December 2008. The proposed Administrators were from a different firm to MCR.
- 3.8 In addition it became apparent that the Group was unlikely to have sufficient funds to continue to pay its employees and the directors made the decision to send employees home indefinitely on 31 December 2008.
- 3.9 Zamy Limited purchased the debentures from Barclays Bank Plc on 28 January 2009 and replaced Barclays as the holder of the Qualifying Floating Charges over all the companies within the Group secured by virtue of cross guarantees.

#### **Appointment of Joint Administrators**

- 3.10 In view of the winding up petition, the directors were prevented from making an immediate appointment under the provisions of the Insolvency Act as a court hearing would have been necessary.
- 3.11 In its position of Qualifying Floating Charge Holder and in order to protect its investment Zayma Limited took the decision to appoint Administrators.
- 3.11 The Joint Administrators considered the position prior to accepting the appointment and, having regard to the Insolvency Practitioners Association's ethical guidelines, considered that there were no circumstances preventing them from accepting the appointment.
- 3.12 Subsequently David John Whitehouse and I were appointed Joint Administrators on 29 January 2009.

#### **4. PURPOSE OF THE ADMINISTRATION**

- 4.1 The purpose of an Administration is to achieve one or more of the following hierarchical objectives:
  - Rescuing the Company as a going concern, or
  - Achieving a better result for the Company's creditors as a whole than would be likely if the Company were wound up (without first being in Administration), or
  - Realising property in order to make a distribution to one or more secured or preferential creditors.

In accordance with paragraph 49(2) of the Insolvency Act 1986, as amended, the Joint Administrators believe that the first objective referred to above cannot be met. The detailed explanation for this situation is contained within the following sections of this report but in summary the reason is that the Company's liabilities outweighed the assets and that the working capital requirement of the Company would make it an unattractive proposition to a potential purchaser.

## **5. PROGRESS OF THE ADMINISTRATION TO DATE**

- 5.1 The manner in which the affairs and business of the Company have been managed since the appointment of Joint Administrators and will continue to be managed and financed is set out below.

### **Administration trading period**

- 5.2 Following the appointment of the Joint Administrators, a high level financial review of the Group operations and the short term trading prospects of the Group was carried out. It was determined that in order to maximise the potential for a going concern sale of the business and assets of the Group, trading operations should be maintained whilst the Joint Administrators further evaluated the Group's financial position and marketed the business to interested parties.
- 5.3 It became apparent during the initial review of trading that the ongoing costs of trading were high in comparison to the forecast trading sales. Accordingly the Joint Administrators had no option but to announce the closure of eight stores retaining the five key contributing outlets. In addition 36 employees were made redundant in order to reduce costs. 114 employees were retained and trading was undertaken on a "business as usual" basis as far as possible whilst a sale of the Company's business and assets was sought.
- 5.4 The Joint Administrators took the decision to resurrect the website and recommence online operations as this is a key asset of the Group. Prior to the suspension of the website a number of orders were taken and remained unfulfilled at the date of our appointment. The Joint Administrators took the decision to cancel these unfulfilled orders.
- 5.5 In order to minimise disruption to trading, the Joint Administrators reached an agreement with the third party warehouse who supplied stock holding and despatch services. Prior to this the retail stores had traded without new stock for approximately 10 weeks. This agreement ensured the stores were replenished with existing stock lines which the Joint Administrators expected to increase Administration sales.
- 5.6 It is projected that the trading period will result in a breakeven position. This is subject to reconciliation and any unforeseen expenses, however, the Joint Administrators do not anticipate this to change significantly.

### **Sale of business and assets**

- 5.7 The Joint Administrators received a total of 16 expressions of interest in the purchase of the business and assets of the Group. 10 of those parties returned confidentiality agreements and were provided with a copy of the Sale of Business Information Memorandum.
- 5.8 Given the nature of the Group's business and the fact that the Group had traded at an extremely reduced level for the past 10 weeks, in order to preserve the value of the Group, it was essential that the sale process was progressed as quickly as possible and therefore the Joint Administrators set an initial offer deadline of Thursday 5 February 2009.
- 5.9 At the date of this report no sale has been agreed.



- 5.10 In accordance with SIP 13 other than those within the Group there is no evidence of any related party transactions to date.

### **Investigations**

- 5.11 The Joint Administrators' investigations into the Company's affairs are currently ongoing.
- 5.12 The Joint Administrators have a statutory obligation to file a report with the Insolvency Service regarding the conduct of the directors that held office in the three years prior to the Administration. This report must be filed within six months from the appointment date and the content of this report is confidential.
- 5.13 The Joint Administrators also have a duty to investigate antecedent transactions which include:
- Transactions at an undervalue, s238 of the Insolvency Act 1986;
  - Preferences, s239 of the Insolvency Act 1986; and
  - Transactions to defraud creditors, s423 of the Insolvency Act 1986.

### **Receipts and Payments**

- 5.14 A detailed receipts and payments account is shown in Appendix 2.
- 5.15 There have been no receipts in respect of the Company to date.
- 5.16 Salaries of £17,701 were paid for the initial 4 day trading period, these have been recorded in the receipts and payments account of BM and there will be a re-allocation to TMG.
- 5.17 A payment of £28,750 was made to Parcelnet for the ongoing provision of services in respect of the third party warehouse, again an element of these will be re-allocated to TMG.

## **6. STATEMENT OF AFFAIRS**

- 6.1 In accordance with Paragraph 47 of Schedule B1 to the Insolvency Act 1986 the Joint Administrators have requested that the directors provide them with a statement of the affairs ("SOA") of the Company. At present the statement of affairs has not yet been provided and in accordance with Rule 2.33(2) we have estimated the financial position of the Company at Appendix 3.
- 6.2 The latest management information available was dated 31 October 2008.
- 6.3 A schedule of creditors' names and addresses is attached at Appendix 4. Some creditor amounts shown may differ from the actual amount owed. This does not affect their claim. Please complete and return a Proof of Debt form (attached at Appendix 7) if you have not already done so.

## **7. JOINT ADMINISTRATORS' REMUNERATION**

- 7.1 In accordance with Rule 2.106 of the Insolvency Rules 1986, as amended, it is proposed that the basis upon which the Joint Administrators' remuneration should be fixed, is by reference to the time properly given by them and their staff in attending to matters arising in the Administration.
- 7.2 The Joint Administrators will be seeking the subsequent approval of the secured and preferential creditors in respect of their remuneration pursuant to Rule 2.106(5A) of the Insolvency Rules 1986, as amended.

- 7.3 The Joint Administrators' time costs for the period 28 January 2009 up to and including 6 February 2009 are £3,632.00. Note that any time-costs relating to the shared overhead of the business and trading have been recorded on the BM time-code ledger at present as it is not possible to accurately apportion costs between BM and TMG. A schedule of TMG time costs is set out at Appendix 5.
- 7.4 To date, no remuneration has been drawn by the Joint Administrators.

## **8. DIVIDEND PROSPECTS / PRESCRIBED PART**

### **Secured Creditors**

- 8.1 In consideration for monies advanced the Company granted Zamyra a debenture, which confers fixed and floating charges over all of the assets of the Company. This was secured by cross-corporate guarantees and debentures from all of the companies in the Group.
- 8.2 At the date of the Joint Administrators' appointment, the Company's indebtedness to Zamyra was approximately £845,000 subject to accruing interest and charges. The Joint Administrators expect that there will be insufficient realisations to repay the secured creditor.

### **Preferential Creditors**

- 8.3 In the absence of the directors' SOA, the estimated preferential claims of the Group are £117,000 of which approximately £50,000 relate to TMG.
- 8.4 It is not known if there will be sufficient funds available to enable a distribution to preferential creditors.
- 8.5 It is likely that a significant element of the preferential claim will be employees' claims which are mostly subrogated to the Secretary of State, following payment by the Redundancy Payments Office.

### **Prescribed Part**

- 8.6 Pursuant to section 176A of the Insolvency Act 1986 where a floating charge is created after 15 September 2003 a prescribed part of the company's net property shall be made available to unsecured creditors.
- 8.7 The prescribed part is calculated as a percentage of net property, as follows:-
- |                                    |   |
|------------------------------------|---|

| Net property greater than £10,000: | 50% up to £10,000 plus 20% thereafter to a maximum of £600,000. |

- 8.8 The maximum value of the ring-fenced proportion of the funds, known as the "prescribed part", is £600,000. It is not possible to estimate the value of any prescribed part at this stage.

### **Non-Preferential Creditors**

- 8.9 According to the information available, non-preferential trade and expense creditors are estimated to be £2,659,800.52. A detailed schedule of these is included in Appendix 4.

- 8.10 It is not known if there will be sufficient realisations to enable a distribution to the non-preferential creditors of the Company.

## **9. EC REGULATION**

- 9.1 It is the Joint Administrators' opinion that the EC Regulation on Insolvency Proceedings 2000 ("EC Regulation") applies and these proceedings are main proceedings as defined in Article 3 of the EC Regulation. The centre of main interests of the Company is in England.

## **10. CREDITORS' MEETING**

- 10.1 In accordance with Paragraph 52(1)(b) of Schedule B1 to the Insolvency Act 1986, a creditors' meeting will not be convened as the Joint Administrators believe that the Company will have insufficient property to enable a distribution to be made to unsecured creditors, other than the prescribed part.
- 10.2 However, the Joint Administrators shall summon an initial creditors' meeting, if requested to by the creditors of the Company, whose debts amount to at least 10% of the total debts of the Company, using the prescribed form 2.21B, attached at Appendix 6, within 12 days from the date of this report.
- 10.3 Creditors are reminded that the costs of any meeting called shall be paid for by them and that a deposit will be required for such purpose. Such costs may be ordered to be paid as an expense of the Administration if the meeting so resolves.

## **11. END OF THE ADMINISTRATION**

- 11.1 The options available to the Joint Administrators for the exit from the Administration are as follows:
- Compulsory Liquidation
  - Creditors' Voluntary Liquidation
  - Company Voluntary Arrangement
  - Return of control to the Director
  - Dissolution of Company
- 11.2 We are yet to form a view and, therefore, to make our recommendation on this issue. We are still investigating the Company's affairs and business.

## **12. JOINT ADMINISTRATORS' PROPOSALS**


- 12.1 The Joint Administrators propose the following:
- 12.1.1 That the Joint Administrators continue the Administration to deal with such outstanding matters in relation to the Company as the Joint Administrators consider necessary until such time as the Administration ceases to have effect.
- 12.1.2 That the Joint Administrators do all such other things and generally exercise all of their powers as contained in Schedule 1 of the Insolvency Act 1986, as they, in their sole and absolute discretion consider desirable or expedient in order to achieve the purpose of the Administration.
- 12.1.3 That the Joint Administrators seek an extension to the Administration period if deemed necessary.

- 12.1.4 That the Joint Administrators, once all outstanding matters have been satisfactorily completed, take the necessary steps under paragraph 84 of Schedule B1 of the Insolvency Act 1986 to the Registrar of Companies to the effect that the Company has no property which might permit a distribution to its creditors, at which stage the Administration will cease.
- 12.1.5 That the Joint Administrators, in the event that they form the view that a distribution can be made to unsecured creditors, take the necessary steps to put the Company into creditors' voluntary liquidation. It is proposed that the Joint Administrators, currently Philip Francis Duffy and David John Whitehouse of MCR would act as Joint Liquidators should the Company be placed into creditors' voluntary liquidation. In accordance with Paragraph 83(7) of Schedule B1 to the Insolvency Act 1986 and Rule 2.117(3) of the Insolvency Rules 1986 (as amended) the creditors may nominate a different person as the proposed Liquidator, provided such nomination is made before these proposals are approved.
- 12.1.6 That the Joint Administrators be discharged from all liability pursuant to paragraph 98 of Schedule B1 to the Insolvency Act 1986, upon filing the end of the Administration or their appointment otherwise ceasing.
- 12.1.7 That the Joint Administrators' remuneration be fixed by reference to the time properly spent by them and their staff in attending to matters arising in the administration.
- 12.1.8 That the Joint Administrators be authorised to draw their firm's internal costs and expenses in dealing with the administration ("Category 2 Disbursements"), if any.
- 12.1.9 That the Joint Administrators be authorised to instruct and pay MCR Receivables Management Limited to assist with the collection of book debts, where considered appropriate.
- 12.2 Pursuant to Rule 2.33(5) of the Insolvency Rules 1986, the proposals in paragraph 12.1 shall be deemed to be approved by the creditors on the expiry of the period in which a meeting can be requisitioned by creditors in the manner described in paragraph 10.2 above, provided that no meeting has been so requisitioned.
- 12.3 The Joint Administrators will be seeking the following resolutions from the secured creditors and preferential creditors:
- 12.3.1 That the Joint Administrators be discharged from all liability pursuant to paragraph 98 of Schedule B1 to the Insolvency Act 1986, upon filing the end of the Administration.
- 12.3.2 That the Joint Administrators' remuneration be fixed by reference to the time properly spent by them and their staff in attending to matters arising in the administration.
- 12.3.3 That the Joint Administrators be authorised to draw their firm's internal costs and expenses in dealing with the administration ("Category 2 Disbursements"), if any.
- 12.3.4 That the Joint Administrators be authorised to instruct and pay MCR Receivables Management Limited to assist with the collection of book debts, where considered appropriate.
- 12.3.5 To extend the Administration periods if deemed necessary by the Joint Administrators, for a period of up to six months.

**13. OTHER MATTERS**

- 13.1 If any creditor has any information concerning the Company's affairs that they would like to bring to our attention, then we should be pleased to hear from them.
