

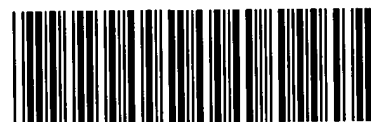
The company is a subsidiary of Quarto Publishing plc.


