HARD COPY PROXY APPOINTMENTS AND VOTING INSTRUCTIONS MUST BE RECEIVED AT THE REGISTERED OFFICE OR SUCH OTHER PLACE (IN THE UK) AS THE COMPANY MAY SPECIFY, NOT LESS THAN 48 HOURS BEFORE THE TIME FOR HOLDING THE MEETING. SUBJECT TO THE APPLICABLE STATUTES, THE COMPANY MAY BY ORDINARY RESOLUTION DECLARE DIVIDENDS, BUT NO DIVIDEND SHALL EXCEED THE AMOUNT RECOMMENDED BY THE BOARD. THE BOARD MAY PAY INTERIM DIVIDENDS IF IT APPEARS TO THE BOARD THAT THEY ARE JUSTIFIED BY THE PROFITS OF THE COMPANY AVAILABLE FOR DISTRIBUTION. IF THE COMPANY IS WOUND UP, THE LIQUIDATOR MAY, WITH THE SANCTION OF A SPECIAL RESOLUTION OF THE COMPANY AND ANY OTHER SANCTION REQUIRED BY APPLICABLE STATUTE: (A) DIVIDE AMONG THE SHAREHOLDERS THE WHOLE OR ANY PART OF THE ASSETS OF THE COMPANY AND MAY, FOR THAT PURPOSE, VALUE ANY ASSETS AND DETERMINE HOW THE DIVISION SHALL BE CARRIED OUT AS BETWEEN THE SHAREHOLDERS OR DIFFERENT CLASSES OF SHAREHOLDERS; (B) VEST THE WHOLE OR ANY PART OF THE ASSETS IN TRUSTEES FOR THE BENEFIT OF SHAREHOLDERS; AND (C) DETERMINE THE SCOPE AND TERMS OF THOSE TRUSTS. NO ORDINARY SHARES ARE TO BE REDEEMED OR ARE LIABLE TO BE REDEEMED AT THE OPTION OF THE COMPANY OR ANY SHAREHOLDER, BUT SUBJECT TO APPLICABLE STATUTES, SHARES MAY BE ISSUED WHICH ARE TO BE REDEEMED OR ARE LIABLE TO BE REDEEMED AT THE OPTION OF THE COMPANY OR ANY SHAREHOLDER IN ACCORDANCE WITH THE COMPANY'S ARTICLES OF ASSOCIATION.
