

ORDER

UPON THE APPLICATION dated 19 May 2021 for a block transfer order (the
“**Application**”)

AND UPON reading the First Witness Statement of David James Kelly (the
“**Applicant**”) dated 19 May 2021

AND UPON notice of the Application having been given to the Secretary of State

IT IS ORDERED that:-

1. Insofar as the Application concerns cases not currently within the jurisdiction of this Court they be transferred to this Court solely for the purpose of and insofar as is necessary for considering the Application and the making of this Order and shall be treated as transferred back without any intervening administrative action forthwith upon the making of this Order.
2. Ian David Green (the “**Outgoing Office Holder**”) be removed from office as administrator or (as relevant) as liquidator of the companies listed in Schedule

2 to this Order (together or, as appropriate, each of them, the “**Companies**”).

3. David James Kelly be appointed to the same offices forthwith upon such removal.

4. The removal of Ian David Green under paragraph 2 above and the appointment of David James Kelly under paragraph 3 above shall take effect at noon on Wednesday 16 June 2021.
5. For the companies listed at numbers 1 to 2 in Schedule 2 of this Order being companies in administration (the “**Companies in Administration**”), in accordance with paragraph 100(2) of Schedule B1 to the Insolvency Act 1986 (the “**Act**”), following the Outgoing Office Holder’s removal as administrator, all functions exercised by the (new) joint administrators (as set out in Schedule 2 of this Order) are to be exercised by any one or all of the joint administrators.
6. For the companies listed at numbers 3 to 5 in Schedule 2 of this Order being companies in creditors’ voluntary liquidation (the “**Companies in CVL**”), in accordance with section 231 of the Act, following the Outgoing Office Holder’s removal as liquidator, any acts required or authorised under any enactment to be done by the (new) joint liquidators (as set out in Schedule 2 of this Order) are to be done by all or any one or more of the joint liquidators.
7. The Applicant shall notify the Secretary of State as soon as reasonably practicable of the making of this Order.
8. The Applicant shall be required to notify the creditors of the Companies of the making of this Order in the following ways only:
 - a. by advertisement in the London Gazette within 28 days following the granting of this Order; and
 - b. by reporting the making of the Order and its effect in the next periodic report sent to all creditors.

The Applicant can publish in the London Gazette composite notices relating to the resignation and the appointments as detailed in Schedule 2 to this Order.

9. The Outgoing Office Holder be discharged from all liability in respect of his acts and omissions and otherwise in respect of his conduct as administrator of the Companies in Administration, to take effect 28 days after publication of the advertisement under paragraph 8 of this Order, and subject to paragraph 12 of this Order.
10. In respect of the Companies in Administration, where the Applicant is appointed to act as a joint administrator by this Order in circumstances where the Outgoing Office Holder was appointed under paragraph 14 or 22 of

Schedule B1 to the Act, he shall obtain his discharge from liability pursuant to paragraph 98(1) of Schedule B1 of the Act on the same basis as those administrators originally appointed in respect of that company. Accordingly, the discharge provided by paragraph 98(1) of Schedule B1 of the Act will take place, in relation to the Applicant, at a time appointed by the resolution of the creditors' committee or, if there is no committee, by resolution of the creditors or in any case at a time specified by the court (and, for the avoidance of doubt, the provisions of 98(3) of Schedule B1 of the Act will apply equally in relation to an appointment made by this Order as it would in relation to the original appointments).

11. The Outgoing Office Holder be released from all liability in respect of his acts and omissions and otherwise in respect of his conduct as liquidator of the Companies in Liquidation upon the granting of the same by the Secretary of State, but subject always to paragraph 12 of this Order.
12. Any creditor of the Companies may apply to vary or discharge this Order by issuing an application within 28 days after publication of the advertisement under paragraph 8 of this Order.
13. The costs of the Application including the Applicant's solicitors' costs, advertising costs, bond fees and court fees are summarily assessed at £10,550 including VAT (the "**Application Costs**") and shall be apportioned equally between the Companies.
