IT IS ORDERED that:-

- 1. Insofar as the Application concerns cases not currently within the jurisdiction of this Court they be transferred to this Court solely for the purpose of and insofar as is necessary for considering the Application and the making of this Order and shall be treated as transferred back without any intervening administrative action forthwith upon the making of this Order.
- 2. Ian David Green (the "Outgoing Office Holder") be removed from office as administrator or (as relevant) as liquidator of the companies listed in Schedule

- 2 to this Order (together or, as appropriate, each of them, the "Companies").
- 3. David James Kelly be appointed to the same offices forthwith upon such removal.

- 4. The removal of Ian David Green under paragraph 2 above and the appointment of David James Kelly under paragraph 3 above shall take effect at noon on Wednesday 16 June 2021.
- 5. For the companies listed at numbers 1 to 2 in Schedule 2 of this Order being companies in administration (the "Companies in Administration"), in accordance with paragraph 100(2) of Schedule B1 to the Insolvency Act 1986 (the "Act"), following the Outgoing Office Holder's removal as administrator, all functions exercised by the (new) joint administrators (as set out in Schedule 2 of this Order) are to be exercised by any one or all of the joint administrators.
- 6. For the companies listed at numbers 3 to 5 in Schedule 2 of this Order being companies in creditors' voluntary liquidation (the "Companies in CVL"), in accordance with section 231 of the Act, following the Outgoing Office Holder's removal as liquidator, any acts required or authorised under any enactment to be done by the (new) joint liquidators (as set out in Schedule 2 of this Order) are to be done by all or any one or more of the joint liquidators.
