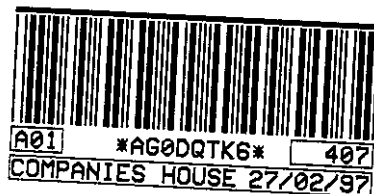


Accounting Reference Date


