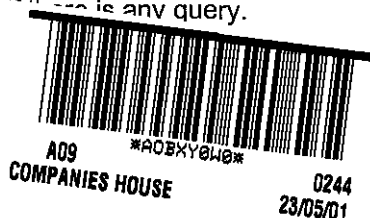

## NOTES
