1 Introduction

- 1.1 THIS REPORT is made by Daniel Francis Butters, licensed Insolvency Practitioner of Deloitte LLP, 1 New Street Square, London, EC4A 3HQ (the "Chair") pursuant to the provisions of sections 4(6) and 4(6A) of the Insolvency Act 1986 (the "Act") and Rule 2.38 of the Insolvency Rules 2016 (the "Rules"). This is the Chair's Report on the result of the decision of creditors as taken at a virtual meeting and of the meeting of the member of New Look Retailers Limited (the "Company") contemplated by such sections and Rule.
- Any capitalised terms contained in this report not defined herein shall have the same meaning attributed to them in the proposal by the Company for a company voluntary arrangement under Part I of the Act issued on 26 August 2020 (the "Proposal").

2 Decision from Creditors

- Pursuant to section 3 of the Act, the decision from creditors was taken at a virtual meeting held at 11:00 a.m. on 15 September 2020.
- 2.2 The Chair briefly explained at the meeting of creditors that the legislation which dealt with voluntary arrangements was contained in Part I of the Act.
- 2.3 The Chair advised those present at the meeting that as convenor of the meeting and pursuant to Rule 2.34 he was the Chair thereof.
- 2.4 One modification to the Proposal, as issued on 26 August 2020, had been proposed by a creditor in advance of the meeting however this was not approved by the Chair as it was not agreed by the Company and was not in the interest of the Company or its creditors. No further modifications were proposed by a creditor (or any person entitled to do so) at the meeting.

- 2.5 The following resolution (the "Creditors' Resolution") was then proposed:
 - "That the Proposal for a CVA be approved, in accordance with section 4 Insolvency Act 1986, which incorporates the appointment of Daniel Francis Butters and Robert Scott Fishman as Joint Supervisors of the CVA and confirmation that any act to be done by the Joint Supervisors in connection with the CVA may be done by any one or more of them."
- 2.6 A vote was then taken on the Creditors' Resolution. Set out in Schedule 1 to this report is a list of the creditors (with their respective values) who were present or represented at the meeting, showing how they voted on the Creditors' Resolution. The Chair considers that certain information relating to the identity of certain creditors who voted at the meeting is confidential and so should be excluded from Schedule 1 pursuant to Rule 1.58 Insolvency (England and Wales) Rules 2016, though a summary of those votes is provided in Schedule 1.
- 2.7 It was noted that to become effective, the Proposal must be voted in favour of by 75% or more (in value) of those creditors responding. However, the Proposal will not be approved if more than 50% of the total value of the unconnected creditors vote against it. Having regard (inter alia) to the provisions of Rule 15.31 the Chair declared the Creditors' Resolution passed.
- 2.8 Accordingly, the Proposal as issued on 26 August 2020 was approved by the creditors without modification.

3 Meeting of the Company

- Pursuant to section 3 of the Act, the meeting of the Company took place by way of physical meeting at 3:00 p.m. on 15 September 2020.
- 3.2 The Chair explained at the meeting of the Company that the legislation which dealt with company voluntary arrangements was contained in Part I of the Act.
- 3.3 The Chair advised those present at the meeting that as convenor of the meeting and pursuant to Rule 2.34 he was the Chair thereof.
- 3.4 One modification to the Proposal, as issued on 26 August 2020, had been proposed by a creditor in advance of the meeting however this was not approved by the Chair as it was not agreed by the Company and was not in the interest of the Company or its creditors. No further modifications were proposed by the member (or any person entitled to do so) at the meeting.
- 3.5 The following resolution (the "Member's Resolution") was then proposed:
 - "That the Proposal for a CVA be approved, in accordance with section 4 Insolvency Act 1986, which incorporates the appointment of Daniel Francis Butters and Robert Scott Fishman as Joint Supervisors of the CVA and confirmation that any act to be done by the Joint Supervisors in connection with the CVA may be done by any one or more of them."
- 3.6 A vote was then taken on the Member's Resolution. Set out in Schedule 2 to this report are details of the member who was represented at the meeting and how it voted on the Member's Resolution.
- 3.7 Having regard (inter alia) to the provisions of rule 2.36 the Chair declared the Member's Resolution passed.

- 3.8 Accordingly, the Proposal as issued on 26 August 2020 was approved by the member without modification.
- 4 EC Regulation on Insolvency Proceedings

In the opinion of the Supervisors, the EC Regulation on Insolvency Proceedings applies to the voluntary arrangement and these proceedings are main proceedings as defined by Article 3 of that regulation.
