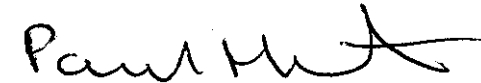
For the period ended 31 December 2006 the company was entitled to exemption under Section 249AA (1) of the Companies Act 1985.
