DIRECTORS' REPORT

The directors present their report and the audited financial statements for the 53 weeks ended 30 December 2012

PRINCIPAL ACTIVITIES, REVIEW OF THE BUSINESS AND FUTURE PROSPECTS

The company did not trade during the period

On 10 December 2012 a special resolution was passed to reduce the share capital of the company by the cancellation of £5,197,000 from the share premium account and transfer that amount to the profit and loss reserve. The company wrote down its investment in its subsidiaries by £157,000 in the period

Since 10 December 2012 the company has been a dormant employing company and has continued not to trade. The directors expect this to continue

PRINCIPAL RISKS AND UNCERTAINTIES

The company is a wholly owned subsidiary within the Gannett Co, Inc group of companies All of its material transactions are with fellow group undertakings and as such its activities are dependent on the activities of the Gannett Co, Inc group of companies as a whole

The risks and uncertainties facing the company are linked to those of the group A discussion of the Group risks and uncertainties is contained in the group's annual report

RESULTS AND DIVIDENDS

The loss on ordinary activities after taxation amounted to £157,000 (2011 - £nil)

A dividend of £10,079,000 was made during the year (2011 - £nil) The directors do not recommend a final dividend (2011 - £nil)

1 ACCOUNTING POLICIES

Basis of preparation of financial statements

The financial statements have been prepared under the historical cost convention and in accordance with applicable accounting standards

Accounting period

The profit and loss accounts cover the 53 weeks from 26 December 2011 to 30 December 2012 and 52 weeks from 26 December 2011 to 30 December 2012. The balance sheets for 2012 and 2011 have been drawn up at 30 December 2012 and 25 December 2011 respectively

Investments

Investments held as fixed assets are stated at cost, less provision, if appropriate, for any impairment in value other than a temporary impairment in value

The carrying value of investments is reviewed for impairment in periods if events or changes in circumstances indicate the carrying value may not be recoverable

Group accounts and cash flow statement

The company, as it is a wholly owned subsidiary itself, is not required to prepare group accounts because its parent undertaking is established under the law of an EEA state. Accordingly the financial statements present information about the company rather than the group as a whole. A cash flow statement is not required under Financial Reporting Standard 1 (revised), as the company is a wholly owned subsidiary and the group's financial statements are publicly available.

Tax losses arising within the Gannett UK Limited group of companies are relieved amongst group companies. The principal factor that may affect the tax charge in future periods is the basis on which tax losses are allocated within the group and the rate (if any) at which the company pays for those losses

On 20 March 2013, the UK government confirmed its intention to propose that Parliament reduce the main rate of UK corporation tax to 20% from 1 April 2015. The rate has been reducing and enacted rates are 24% with effect from 1 April 2012 and 23% with effect from 1 April 2013. Reduction of the rate to 21% from 1 April 2014 and to 20% from 1 April 2015 is expected to be enacted during 2013.
