REPORT OF THE AUDITORS TO THE MEMBERS OF

CANNOCK CHEMICALS LIMITED

UNDER PARAGRAPH 24 OF SCHEDULE 8 OF THE COMPANIES ACT 1985

We have examined the abbreviated financial statements on pages 3 to 6 together with the full financial statements of Cannock Chemicals Limited for the year ended 30 September 2000. The scope of our work for the purpose of this report was limited to confirming that the company is entitled to the exemptions claimed in the directors' statement on page 2 and that the abbreviated financial statements have been properly prepared from the full financial statements.

In our opinion the company is entitled under Sections 246 to 247 of the Companies Act 1985 to the exemptions conferred by Section A of Part III of Schedule 8 to that Act in respect of the year ended 30 September 2000 and the abbreviated accounts on pages 3 to 6 have been properly prepared in accordance with that schedule.

On 9 November 2000 we reported, as auditors of Cannock Chemicals Limited to the members on the full financial statements prepared under section 226 of the Companies Act 1985 for the year ended 30 September 2000 and our audit report was as follows:-

Respective responsibilities of directors and auditors

As described on page 2, the company's directors are responsible for the preparation of financial statements. It is our responsibility to form an independent opinion, based on our audit, on those statements and to report our opinion to you.

Basis of opinion

We conducted our audit in accordance with Auditing Standards issued by the Auditing Practices Board. An audit includes examination, on a test basis, of evidence relevant to the amounts and disclosures in the financial statements. It also includes an assessment of the significant estimates and judgements made by the directors in the preparation of the financial statements, and of whether the accounting policies are appropriate to the company's circumstances, consistently applied and adequately disclosed.



NOTES ON THE ABBREVIATED ACCOUNTS

YEAR ENDED - 30 SEPTEMBER 2000

1. ACCOUNTING POLICIES

Basis of accounting

The accounts have been prepared in accordance with applicable accounting standards and under the historical cost convention.

Cash flow statement

The company has taken advantage of the exemption from preparing a cash flow statement conferred by Financial Reporting Standards No: 1 on the grounds that it is entitled to exemptions available in Section 246 to 247 of the Companies Act 1985 for small companies.

Depreciation

Depreciation of fixed assets is calculated in order to write off the cost of tangible fixed assets on a reducing basis or straight line basis commencing with the year of acquisition over their estimated useful lives:

Plant and machinery	-	15% - reducing basis
Fixtures and fittings	-	15% - reducing basis
Motor vehicles	-	25% - reducing basis
Computer equipment	-	25% - straight line basis

The leasehold improvements are being written off by equal annual amounts over the remaining period of the lease.

Stocks

Stocks are valued at the lower of cost and net realisable value. Cost is computed on a first in first out basis. The cost of work in progress and finished goods includes all production overheads and depreciation and the attributable proportion of indirect overheads based on the normal level of activity. Net realisable value is based on estimated selling price less the estimated cost of disposal.

Deferred taxation

Deferred taxation takes account of timing differences between the treatment of certain items for accounts purposes and their treatment for taxation purposes using the liability method. The amount provided in the accounts is only that liability which is expected to crystallise within the foreseeable future.

Defined contributions scheme

Pension contributions are charged to the profit and loss account as they become payable in accordance with the rules of the Pension Scheme.

Lease & hire purchase contracts

Tangible fixed assets acquired under finance leases and hire purchase contracts are capitalised at the estimated fair value at the date of inception of each lease or contract. The total finance charges are allocated over the period of the lease in such a way as to give a reasonable constant charge on the outstanding liability.
