
Audit Exemption Statement

1 GENERAL INFORMATION

GDS Instruments Limited is a company limited by shares. It was incorporated in England and its registered office is 52c Borough High Street, London SE1 1XN. The principal activity of the company is that of a dormant company and as such does not carry out a trade of its own.

2 ACCOUNTING POLICIES

Statement of Compliance

The financial statements were prepared in accordance with FRS 101 'Reduced Disclosure Framework'.

Basis of preparation

The Company meets the definition of a qualifying entity under FRS 101. The financial statements have therefore been prepared in accordance with FRS 101 as issued by the Financial Reporting Council.

As permitted by FRS 101, for both periods presented, the Company has taken advantage of the disclosure exemptions available under that standard in relation to financial instruments, capital management, share based payments, fair value measurements, comparative reconciliations for tangible and intangible assets, standards not yet effective, related party transactions with other wholly-owned members of the group and key management personnel compensation. Equivalent disclosures are, where required, given in the group accounts of Judges Scientific plc. The group accounts of Judges Scientific plc are available to the public.
