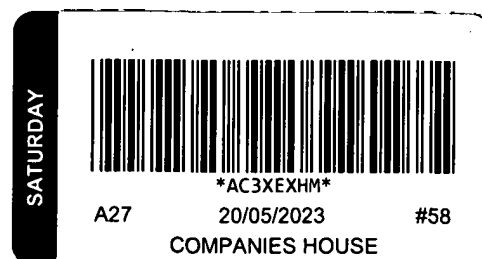

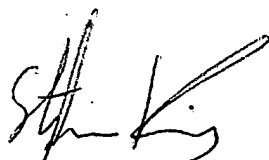
Directors' responsibilities
