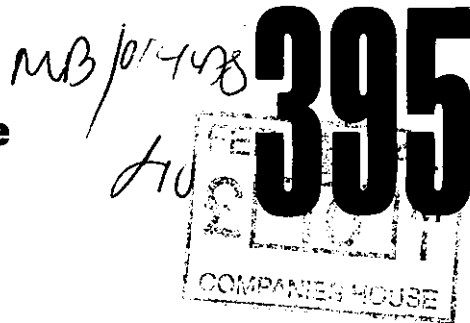

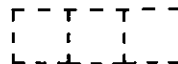

1.
