OR IF HIS INTEREST THEREIN FOR ANY REASON CEASES AND DETERMINES. HE OR. IN THE EVENT OF HIS DEATH, HIS LEGAL REPRESENTATIVES. OR IN THE EVENT OF HIS BANKRUPTCY. HIS TRUSTEE IN BANKRUPTCY SHALL TRANSFER HIS SHARE IN THE COMPANY TO THE PERSON OR PERSONS BECOMING DWELLING HOLDER OF THE SAID DWELLING IN HIS PLACE. IN NOMINAL VALUE OF THE SHARES GIVING THAT RIGHT.
