CONSENT ORDER

UPON THE APPLICATION of Allan Watson Graham of KPMG LLP, 15 Canada Square, London E14 5GL (the "First Applicant")

AND UPON READING the Witness Statement of Allan Watson Graham dated 25 September 2016 and Exhibit AWG1 thereto

IT IS ORDERED BY CONSENT THAT:

1. The cases listed in Schedules A to E attached to this Order, in so far as there are currently proceedings in the County Court or in a District Registry be transferred to the High Court in London for the purpose of making the Orders listed below. The cases transferred from the County Court are transferred back to the relevant court upon the making of this Order and the First Applicant shall ensure a copy of this Order is added to the respective insolvency files
2. The First Applicant be removed from office as Administrator with immediate effect pursuant to paragraph 88 of Schedule B1 to the Insolvency Act 1986 of each of the companies listed at rows 1 to 2 of Schedule A to this Order. - 13 Nothing in this Order requires the time for production of any progress report in respect of the estates listed in Schedules A to E of this Order to be varied
- 14 Pursuant to paragraph 98(2)(c) of Section B1 of the Insolvency Act 1986, the First Applicant be discharged from liability in respect of any of his actions as administrator in respect of the estates listed in Schedule A
- 14 1 If no application is made pursuant to paragraph 12 above, on the date being 57 days from the date of advertisement referred to in paragraph 11 above of this order, or
- 14 2 If an application is made pursuant to paragraph 12 above, at such time as should be subsequently ordered by the Court
- 15 The time for service of the Application Notice upon the Respondents be abridged.
