NOTES TO THE FINANCIAL STATEMENTS

For the financial year ended 31 December 2005

1. ACCOUNTING POLICIES

The financial statements have been prepared under the historical cost convention and are in accordance with the Companies Act 1985 and applicable accounting standards in the United Kingdom.

Basis of preparation

The balance sheet shows that liabilities exceed assets by £11,000 at 31 December 2005. Budgens Stores Limited, the immediate parent undertaking has confirmed its intention to ensure the company has sufficient cash to finance its operations and meet its obligations for the foreseeable future. Consequently, the financial statements have been prepared on a going concern basis.

The following are the principal accounting policies used by the company, which, unless otherwise stated, are consistent with those of the previous years.

Consolidation

The financial statements contain information about Neighbourhood Stores plc as an individual company and do not contain consolidated financial information as the parent of a group. The company is exempt under section 228 of the Companies Act 1985 from the requirement to prepare consolidated financial statements as it and its subsidiary undertaking are included by full consolidation in the consolidated financial statements of its ultimate parent, Musgrave Group plc, a company registered in the Republic of Ireland.

Investments in subsidiaries

Investments in subsidiaries are held at cost less provision for permanent diminution in value.

Investments are subject to an annual review for impairment in accordance with Financial Reporting Standard 11 "Impairment of Fixed Assets and Goodwill".

2. PROFIT AND LOSS ACCOUNT

The company has not traded throughout the current financial year ended 31 December 2005, or the preceding period ended 31 December 2004. As a result the company has made neither a profit nor a loss or any other recognised gains and losses during the current financial year or the preceding financial period ended 31 December 2004.

3. DIRECTORS AND EMPLOYEES

In respect of the company, remuneration of the directors for the current year is £ nil (period ended 31 December 2004: £ nil). All directors are employees of Budgens Stores Limited and were remunerated by Budgens Stores Limited for their services as Budgens' employees.
