IT IS ORDERED THAT:

- 1 In respect of those Individual Voluntary Arrangements, Company Voluntary Arrangements and Administration listed in the Schedules appended hereto this Application which are the subject of proceedings in County Courts, those proceedings to be transferred to the High Court solely for the purposes of making the Orders contained herein and thereafter transferred back to the relevant County Court
- 2 The First Respondent be removed from office as Individual and Company Voluntary Arrangements Supervisor and Administrator of the estates listed in the Schedules appended hereto with immediate effect pursuant to Section 263(5) of the Insolvency Act 1986
- 3 The First Respondent be replaced as such office holder in the case of each such estate by the Applicants as particularised in the Schedules appended hereto with immediate effect pursuant to Section 263(5) of the Insolvency Act 1986
- 4 The Applicants be entitled to publish in the Gazette one complete notice relating to all new appointments which is required by law and that the advertisement do contain specifically the following
 - 4 1 The effect of any Order made pursuant to this Originating Application,
 - 4 2 That any individual creditor may apply to this Court within 28 days of the date of such advertisement for reconsideration of the removal of the First Respondent and his replacement by the Applicant as Individual and Company Voluntary Arrangement Supervisor and Administrator in which that creditor stands as such,
 - 4 3 That any individual creditor may require the Applicants to provide an account of his administration of those estates in which that creditor stands as a creditor Such account to include a summary of the Applicants' receipts

and payments, together with a statement that they have reconciled their accounts

- 5 Liberty to apply to the Applicants, Respondents or to any creditor in any of the estates within 28 days of the receipt of correspondence particularised in Paragraph 4 above
- 6 That the costs of and occasioned by the Application be borne by each of the Insolvency Matters and shall be as a proper cost or expense of each such matter save that the costs attributable to any one of the matters shall not exceed 10% of the realisations in that case.
