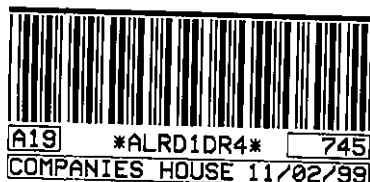

NOTES
