

1 Accounting policies

Basis of preparation

The financial statements have been prepared in accordance with applicable accounting standards and under the historical cost accounting rules

6 Change of ownership and accounting date

On 29 July 2007, Co-operative Group (CWS) Limited accepted the transfer of engagements of United Co-operatives Limited, the company's parent undertaking. On 3rd December 2007, Co-operative Group (CWS) Limited changed its name to Co-operative Group Limited. To be in line with the reporting of fellow subsidiaries in the group, the company has changed its accounting reference date to 11 January.

7 Ultimate parent undertaking

The company is a wholly owned subsidiary of Co-operative Group Limited (formerly known as Co-operative Group (CWS) Limited), an Industrial and Provident Society registered in England and Wales. This is the smallest and largest group of which the company is a member and for which consolidated accounts are prepared.
