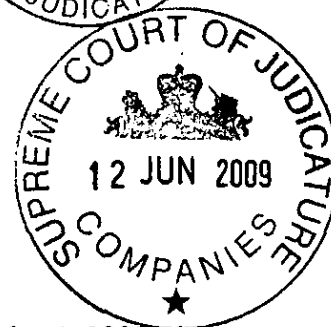
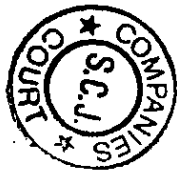

and (2) receive and distribute a note in respect of the said share
transfer

- (1) the name of the above named SCI Developments Limited be restored to the Register of Companies



- (2) an Office Copy of the Order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the Company is thereupon to be deemed to have continued in existence as if its name had not been struck off



- (3) the Registrar of Companies do advertise notice of this Order in his official name in the "London Gazette"

- (4) the Claimants the Company and Shelly Lynn Byers and Sanmina-SCI Systems Holdings Inc do jointly and severally pay to the

Registrar of Companies his costs of the said Application in the
agreed sum of £300-00

(5) the hearing fixed for the 12th June 2009 be vacated

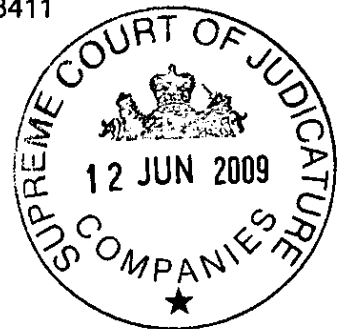
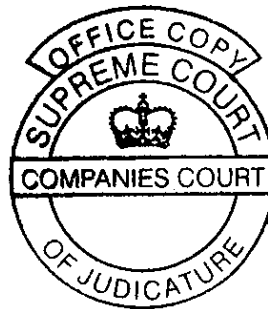
