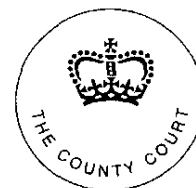

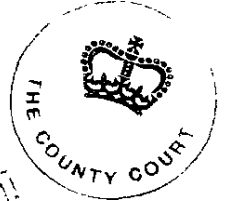

UPON THE APPLICATION by a Claim Form dated the 30th May 2018 of Matthew James Light the Claimant and a director of the above named County Property Management Limited (hereinafter called "the Company")

AND IT APPEARING that there is no opposition on behalf of Her Majesty to the relief sought by this Claim as appears from the Evidence of Service of Matthew James Light and the exhibit thereto

AND the Claimant undertaking that:

- (A) the company will not carry on business or operate in any way other than to take the necessary steps to realise and distribute the funds in the bank account referred to in paragraph 9 of the Witness Statement of Matthew Light dated the 15th May 2018 (the action) according to law

- (1) the name of the above named County Property Management Limited be restored to the Register of Companies
- (2) if at the date of registration of this Order with the Registrar of Companies the name of the Company is not available the Registrar of Companies shall pursuant to Section 1033(2)(a)(ii) and (b) of the Companies Act 2006 change the name of the Company to 01756181 Limited
- (3) an Office Copy of this Order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the company is thereupon to be deemed to have continued in existence as if its name had not been struck off
