UPON THE APPLICATION OF JOHN ALFRED GEORGE ALEXANDER hereafter called
"the Applicant" by notice dated 11 April 2014

AND UPON READING the documents recorded on the Court file as having been read

IT IS ORDERED THAT:-

1. TRANSFER BETWEEN COURTS

- 1.1 The cases set out in the Schedules hereto as being in the County Court be transferred to the High Court pursuant to Rule 7.10C(1)(a) of the Insolvency Rules 1986

2 APPLICANTS REMOVAL AS OFFICEHOLDER

- 2.1 The Applicant be removed as officeholder in the cases set out in the Schedules hereto in accordance with the powers set out in sub paragraphs 2.1.1 to 2.1.5 below and for the avoidance of doubt in any cases where the Applicant is named as a successor officeholder whether as sole or joint Administrator of Liquidator or

as Sole or Joint Nominee to a Supervisor he be replaced by the replacement officeholder on the same terms relating to Fees and Authority:-

2.1.1 Bankruptcy - Section 298 of the Insolvency Act 1986 and Rules 7.10B(2)(c) of the Insolvency Rules 1986,

2.1.2 Members Voluntary Liquidation - Section 108 of the Insolvency Act 1986 and Rule 7.10B(2)(a) of the Insolvency Rules 1986;

2.1.3 Compulsory Liquidation - Section 172(2) of the Insolvency Act 1986 and rule 7.10B(2)(a) of the Insolvency Rules 1986;

2.1.4 Creditors Voluntary Liquidation - Section 108 of the Insolvency Act 1986 and rule 7.10B(2)(a) of the Insolvency Rules 1986;

2.1.5 Administration - paragraph 88 schedule B1 of the Insolvency Act 1986 and rule 7.10B(2)(b) of the Insolvency Rules;

- 3.1 Robin Hamilton Davis to be appointed in substitution for the Applicant as sole office holder in respect of the matters listed in Schedule 1;
- 3.2 John Anthony Dickinson be appointed in substitution for the Applicant as joint office holder with Robin Hamilton Davis for matters set out in Schedule 2,
- 3.3 Robin Hamilton Davis be appointed in substitution for the Applicant as joint office holder with John Anthony Dickinson for matters set out in Schedule 3;
- 3.4 Robin Hamilton Davis be appointed in substitution for the Applicant as joint office holder with Malcolm Cohen for matters set out in Schedule 4;
- 3.5 John Anthony Dickinson be appointed in substitution for the Applicant as joint office holder with Carl James Bowles for matters set out in Schedule 5;
- 3.6 Robin Hamilton Davis be appointed in substitution for the Applicant as joint office holder with Kevin Goldfarb for matters set out in Schedule 6;

4 ADVERTISEMENT REPORTING TO CREDITORS AND RELEASE

- 4.1 As soon as reasonably practicable, and in any event within three months of the date of this Order the Applicant shall procure that a block advertisement is placed in the London Gazette. The advertisement shall contain notification of the removal of the Applicant from the Insolvency proceedings identified in the Schedules hereto and the appointment of the relevant Respondent in his place and shall be in substitution for notifying for each individual creditor on each estate.
- 4.2 The Respondents shall when the next routine report is due to the creditors of each estate notify each creditor of the making of this Order such notice to contain the following matters:
 - 4.2.1 an explanation of the effect of this Order; and
 - 4.2.2 express reference to the liberty to apply contained in paragraph 6 below.
- 4.3 In relation to the Insolvency proceedings listed in the Schedules hereto, and insofar as the Insolvency Act 1986 or the Insolvency Rules 1986 contain any requirement for any appointment of an officeholder to be advertised, the requirement shall be dispensed with save to the extent provided for in paragraph 4.1 above

4.4 The Applicant shall be granted his release 21 days after the publication in the London Gazette referred to in paragraph 4.1 above without being required to apply to the Secretary of State for a release pursuant to Section 173(2)(b), Section 174(4)(b) and Section 299(3)(d) Insolvency Act 1986 as the case may be.

5 DISPENSATION WITH REQUIREMENT TO FILE RECEIPTS AND PAYMENT ACCOUNT

5.1 The Respondents be authorised to dispense with any requirement to file receipts and payments accounts in any of the cases set out in the Schedules hereto as a consequence of the removal and, where appropriate, replacement of the Applicant as an officeholder and the Respondents to file receipts and payments accounts in the normal way

6 LIBERTY TO APPLY TO THE COURT

6.1 Liberty to each creditor of each estate to apply to vary or discharge this Order within 28 days of receipt of the notices directed to be sent under paragraph 4.2 above by each of the Respondents.

AND IT IS HEREBY FURTHER ORDERED:-

7 TRANSFER BETWEEN COURTS

7.1 The cases set out in the Schedules hereto as being in the County Court be transferred back to the relevant County Court as set out in the said Schedule adopting the same case numbers as were used immediately prior to the transfer to the High Court pursuant to Rule 7.10C(1)(b) of the Insolvency Rules 1986 hereto.

8 SERVICE

8.1 The Order to be served on the Secretary of State to whom there be express liberty to apply

9 COSTS

9.1 The costs of this Application (including the VAT) to be paid by Carter Backer Winter of Enterprise House, 21 Buckle Street, Aldgate East, London E1 8NN

9.2 Nothing in paragraph 9.1 above shall prejudice the Applicant and Respondents from:

9.2.1 charging each individual estate the cost of obtaining an Insolvency Practitioners licence bond in respect of that estate; and/or

9.2.2 apportioning between the said estates equally the cost of the composite Gazette notice to be placed under paragraph 4 above
